



BUS PASS APPLICATION FORM 2019 - 20

The cost of the pass for full time 16-18yr old students will be £300.00, other costs apply to Apprentices, HE Students and Adults. This cost can be paid fully at enrolment or split into 2 payments September (£175) and February (£125). Please note that the charge is only a contribution towards the full cost of the transport and you are therefore liable to pay this charge in full irrespective of how often your son/daughter travels on the service provided.

If you wish to apply for assistance with the cost of your bus pass, please provide evidence as requested. You may also be eligible for further financial assistance and Student Services will use this financial information to assess your eligibility and advise you of other support available.

Passes must be collected from Student Central during the first two weeks of September and February. Please note that applications may take up to 2 weeks to process.

Replacement bus passes cost £5 for a College pass or £25 for an Arriva pass.
