

COLLEGE BUS PASS APPLICATION FORM - 2023/24

The cost of the College bus pass for <u>full time 16-18yr old students</u> will be £300, Apprentice cost being £150. This cost can be paid fully at enrolment or split into 2 payments – October 2023 (£175) and February 2024 (£125). Please note that the charge is <u>only a contribution</u> towards the full cost of the transport and you are therefore liable to pay this charge <u>in full</u> *irrespective* of how often your son/daughter travels on the service provided – this is <u>inclusive</u> of the Friday College is not open to students.

If at the beginning of the year (September) or in the second payable term (February) you find that you **do not want to continue with the service, you** <u>must inform us</u> via studentservices@macclesfield.ac.uk.
